# Applying for Kingdom Scholarship

### This form

With this form you can apply for a Kingdom Scholarship if you are enrolled in a full-time program at an educational institution (mbo/sbo, hbo or wo) within the Kingdom of the Netherlands and are going to do an internship or study for at least 2 and maximum 6 months at an educational institution in another part of the Kingdom.

### Send

### At 1 Your details

#### Name

- Have a residence status equivalent to Dutch nationality based on a treaty or decree. Note! This does not apply to students in Curacao.
- Live in the European Netherlands and, according to the Order in Council, belong to a designated group of persons who have the same status as someone with Dutch nationality in terms of study financing.

Do you not have Dutch nationality and do none of the above options apply to your situation? Then describe under 'Other' which nationality you have, and what your situation is. You may not qualify for the subsidy scheme. If you are eligible for study financing but have not applied for it, also indicate this under 'Other'.
