 - the foreign national permanently has left the public bodies;
- I know that in addition the costs, not being costs for assistance that follow for the State and/or the public bodies from the residence of the foreign national, including the costs of a journey of the foreign national to a place outside the public body in which the admittance of the foreign national is guaranteed, may be recovered from me to an annual maximum amount of USD 5000.
- I am aware that, if the foreign national receives a benefit pursuant to the Regeling Onderstand (Assistance Scheme), the costs of the assistance that have been incurred for the benefit of the foreign national (related to the amount of the then applicable benefits according to the standard of the Regeling Onderstand will also be recovered from me.
