1.1 ID number

Please state here the number shown on your ID card (Sédula). The number consists of 10 digits, namely the year (YYYY), month (MM) and day (DD) of your birth, followed by the two final digits.

1.2 First name and surname

Please state your first name, your other initials and your surname as shown in your passport or on your ID card (Sédula).

1.5 Nationality and place of residence

If you do not have Dutch nationality, you must fulfil the following 2 conditions:

- You must have lived in the Caribbean Netherlands for at least 10 years.
- During the 3 months prior to your studies you must have lived in the Caribbean Netherlands.

If you are not Dutch and do not fulfil these 2 conditions, state your nationality under 'Other', on which island you live and how long you have lived there.

2.1 Information by email

You can choose to receive the information about your study financing by email. The benefit of doing so is that you are not dependent on postal deliveries. However, you should make sure that we always have your most recent email address and that our messages do not end up in your spam box.

4.2 Borrowing

Besides your grant or performance-related student loan, you can also borrow money.

NB: You will pay interest on the borrowed amount. You must repay the loan including the interest, even if you graduate.

4.4 Study financing advance

You can have the first month, the first two months, or the first three months of your study financing paid out as an advance. This is only possible if you are not going to study on your home island. If you are going to study in America, Canada, Barbados, Colombia or Puerto Rico, you will receive your study financing twice a year as an advance. Please contact us if you would prefer to receive your study financing every month.

4.5 Payment of advances

The advance will be paid to you as a lump sum. You can choose whether you want to receive the advance one month, two months, or three months before you start studying. NB: This means you will not receive any study financing in the first month, the first two months, or the first three months because you will already have received this as an advance.
