



## Application for allowance for child with intensive care

From the 1<sup>st</sup> of November up until the 30<sup>th</sup> of December 2022, you can apply for an allowance for children requiring intensive care. You can hand in this form at Sentro Aksesio at Kaya Princess Marie 7 or send it by e-mail to [aanvraagkindzorg@aksesobon.com](mailto:aanvraagkindzorg@aksesobon.com).

**You are entitled to the one-off allowance for children with intensive care due to an illness or disorder, if in the period from the 1<sup>st</sup> of November up until the 30<sup>th</sup> of December 2022:**

- you receive child benefit for the child you are applying for;
- the child is or becomes 3 years and older (up to 17 years) in this period;
- there is established intensive care due to illness or disorder.

This may include data recorded by a staff member of Aksesio, data requested from other social workers, care providers or institutions, or data provided by Sentro Aksesio staff member to the The Multidisciplinary Consultative Body (Multidisciplinair Overleg Orgaan, MDO) as part of Fundashon Mariadal (this medical committee assesses your child's care needs).

The aforementioned data will be used to implement the temporary regulation 'Tegemoetkoming kinderen met intensieve zorg BES' by determining whether there is an intensive care need, as mentioned in article 2 of the aforementioned regulation. From this, a medical advice will be issued, which will be used by the RCN unit SZW to determine whether you are eligible for the one-off allowance for parents of children with intensive care needs. The medical advice may also be used to determine whether you qualify for the structural allowance (double child benefit) for parents of children with intensive care needs.
- I hereby give permission to Sentro Aksesio to share the advice resulting from the above with the RCN unit SZW as the decision-making body. In addition to personal data, the exchange concerns only the communication 'positive' or 'negative' advice and a signature of the doctor.

My consent applies only to the processing of the aforementioned data for the purpose of assessing the care needs of the child for whom I have made this application. I may withdraw my consent at any time. In some cases, withdrawing my consent will affect the assessment of my application. I could be informed about this by the RCN unit SZW.
