

Call for the election of the members of the Electoral College for the First Chamber on Wednesday the 15th of March 2023

VOTING PASS

At what times can you vote?

You can vote between 07:30 a.m. and 09:00 p.m.

Where can you vote?

With this voting pass you can vote at all polling stations in your Public Entity on Wednesday the 15th of March 2023.

Polling station near you

Contact details of the Public Entity

Always bring along when you go to the polls:

- This voting pass.
- Your Dutch passport or your identity card or driving licence of your Public Entity. The validity of these documents cannot have expired for more than five years at the time of voting. You can also bring along a residence permit.

Strictly personal!

This voting pass is only valid for the addressee. This pass is the evidence that you can vote and is only valid if your name and address are printed on it. Abuse of this personal voting pass is a punishable offence.

Loss or damage of your voting pass

If the voting pass is lost or damaged then apply for a replacement voting pass in person with your Public Entity. This is possible in writing up to and including Friday the 10th of March2023 or at the service counter up to Tuesday the 14th of March2023, 12:00 noon.

To vote you need proof of identity

Proof of identity is a Dutch passport, or an identity card or driving licence of your Public Entity. The validity of these documents cannot have expired for more than five years at the time of voting. These documents must refer to a date of the 16th of March2018 or a later date under "valid until". You can also provide proof of identity with a residence document.

Do you not have proof of identity?

Then apply for proof of identity with your Public Entity in a timely fashion. If you cannot do this then ask another voter from your Public Entity to vote on your behalf. This is possible by written proxy. You apply for this with your Public Entity. Make sure that your application is received by your Public Entity at the latest on Friday the 10th of March2023.

Are you unable to go to the polling station on the 15th of March2023?

Then you can ask another voter from your Public Entity to vote on your behalf. You can do this in two ways:

1. Complete the proxy certificate alongside and give this – together with a copy of your proof of identity – to the voter who is going to vote on your behalf.

Or:

2. Apply for a written proxy with your Public Entity. Make sure that your Public Entity receives your application at the latest on Friday the 10th of March2023.

Please note! *The law requires that you personally take the initiative for the granting of a proxy and that you personally designate the proxy-holder. Abuse of the proxy is a punishable offence.*

Please note! *Only give this voting pass with a copy of your proof of identity to another person after the proxy certificate below has been completed and signed by you and your proxy-holder.*

PROXY CERTIFICATE

This is my voting pass (my name is mentioned on the front). I do not vote in person and I authorise another person (the proxy-holder) to vote on my behalf. To this end, I gave the said person a copy of my proof of identity.

Signature of the proxy-holder

As a proxy-holder you must:

- cast the proxy vote simultaneously with your own vote;
- bring along a copy of the proof of identity of the person on whose behalf you are voting.

Please note! *You can vote for a maximum of two other votes for the Electoral College elections.*
