General

Always complete sections 1 and 10 of this form and otherwise only the sections which relate to the change.

At 1.1 ID number

Please state here the number shown on your ID card (Sédula). The number consists of 10 digits, namely the year (YYYY), month (MM) and day (DD) of your birth, followed by the two final digits.

At 1.2 First name and surname

Please state your first name, your other initials and your surname as shown in your passport or on your ID card (Sédula).

At 4 Post

You can choose to receive the information about your start-up allowance or BES study financing by email.

The benefit of doing so is that you are not dependent on postal deliveries. However, you should make sure that we always have your most recent email address and that our messages do not end up in your spam box.

At 6.5 Structure of study programme

Do you not know which learning pathway or level you are enrolled in? Then check with the college administration department.

At 6.7 Enrolment date

An academic year in vocational education runs from the 1st of August to the 31st of July, and in higher education from the 1st of September to the 31st of August. If your enrolment starts later in the academic year, for example on the 1st of February, please select 'other' and indicate the date of your enrolment. If you have any doubts about the correct enrolment date, please contact the college administration department.

At 7 Changing the loan

You can change the amount of your loan, or terminate it. If you are not yet borrowing any money, you can also use this form to apply for a loan. NB: You will pay interest on the borrowed amount. You must repay the loan including the interest, even if you graduate.

At 8 Terminating BES study financing or the start-up allowance

If you stop studying, you must terminate your BES study financing or start-up allowance.

At 9 Support with your move to the Netherlands

The supervising organisation will arrange, among other things, your flight to the European Netherlands, support when you arrive in the Netherlands, and help with taking out insurance policies. We will make sure the supervising organisation contacts you. If you wish to make use of this offer of support, you must sign an authorisation showing that you give your permission for us to pay out part of your start-up allowance directly to the supervising organisation. The rest of the start-up allowance will be paid out to you.

If you wish to terminate the support, you must inform the supervising organisation. The entire start-up allowance will then be paid out to you.
